Dear Exhibitors:

The IWPCA Executive Committee has authorized and encourages exhibits at our Annual Meeting in support of the Association's efforts to provide quality educational opportunities.

The exhibits will be open on Wednesday, June 10. The hall will be open for exhibit setup on Tuesday evening from 6:30 to 9 pm and beginning at 8:30 a.m. on Wednesday morning. The displays must be removed Wednesday night after the social is concluded. The Water for People golf outing will be on June 9 with technical sessions on June 10-12.

Wednesday's technical sessions will run from 8:15 a.m. until 3:45 p.m. Exhibit hall will be open all day and the program scheduled exhibitor times include the morning break from 10:15 to 10:45 a.m., a post lunch exhibitor period from 1:15 to 1:45 p.m., and the exhibit hall social from 3:45 p.m. to 6:00 p.m. No other sessions will be held during these times. Beverages and hors d'oeuvres service will start at 3:45 p.m. Cash door prizes ranging from \$50 to \$200 will be given out during the social. Attendees must obtain the signatures/stamps from each of the exhibitors to become eligible for the drawings. The exhibit hall will be open to attendees all day on Wednesday. Water for People Committee will also be holding a silent auction as a fundraiser during the exhibit.

Each exhibit booth will cost \$450 and consist of an 8' wide x 8' deep area with one 6' draped table. The booth includes two chairs, a 7" x 44" identification sign, and electrical power (110 V). The booth cost includes two single day conference registration fees and two Wednesday lunches. **Space will be allocated on a FIRST-PAID basis, so get your reservations in early. Paid reservations are due Friday, May 22, 2009.**

Break, lunch/dinner, and conference sponsorships are also available with sponsors recognized in the program, exhibitor guide, and with signage.

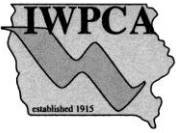

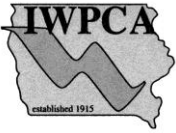

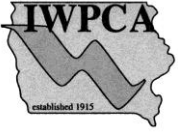
